Your group is being asked to vote on the following items that will be on the ABM agenda:

- 1. The election of Officers of the World Service Board (WSB).
- The election of WSB Members-At-Large. Openings still remain for Board Member-At-Large positions. We appeal to all groups, Intergroups, and National Service Boards for members to take this opportunity to "give back" and serve the fellowship as a WSB member. - 3. Approval of the final financial reports for fiscal year 2023. These will be provided at the ABM.

Also on the ABM agenda will be the annual State of the Fellowship report from the WSB Chair as well as any other necessary business.

It is important that your group cast its vote using **<u>one</u>** of these methods:

- 1. Paper Ballot (form enclosed), or
- 2. Email, or
- 3. By identifying a Delegate (form enclosed) who will participate in the virtual ABM and represent your group, or
- 4. By identifying a Proxy (form enclosed) who will participate in the virtual ABM and vote on behalf of your group.

Complete instructions for voting via any of these methods are located on the ballot.

Note that the deadline for receipt of all ballots and forms submitted via Mail or Email is June 01, 2023.

Those wishing to attend the meeting should reach out to the board chair (email provided below). Within the email, they should indicate the reason for their attendance (either as a delegate, or proxy, or as a general FA member). The board chair will then send a return email to each attendee with a link and instructions for the meeting.
