NEW BUSINESS:

2. MOTION LC-1 (February 2025): The Literature Committee moves that the WSB approve the new literature piece, *Changing Our Attitudes, Changing Ourselves* (#1039). Maria

7. Document Review Committee - Jan

Thanks to Cindy, Greg and Chris Y for reviewing their documents promptly. Encourage the others of you who received emails, to update and send out to WSB for review before making a motion.

As for the PPG-13, Literature Committee procedures, the current PPG does not reflect what happens in reality in the following ways:

- 1. The LC no longer decides on reordering, the Treasurer does.
- 2. The PPG needs to be updated to include PDFs and electronic versions, not just paper copies.
- 3. Translations are currently under PPG-4, International Groups, but in practice, Ann from the LC is solely handling all Translations, from start to finish.

Jan has taken a first stab at updating PPG-13 and sent it out to Ann, Cindy and Maria for review. Jan also reached out to Chair of International Groups regarding transferring the Translation piece which now resides in PPG-4, to PPG-13, but has not heard back (Chair had a fall recently). So question to the Board is if there are thoughts of how to proceed.

Maria suggested that Chair of International Groups will be happy to have Translations taken off her plate. The LC procedures should reflect what is actually happening in terms of Translations and state that the LC will keep the International Groups committee informed and in the loop.

Maria will send out the PPGs that she reviews by email, she has finished one and continues to work on the others.

Chris will send out final version of the Internet policy, PPG-5, as soon as it is completed.

Cindy will add the piece about the Treasurer's role to PPG-13.

8. Succession Planning for Board Members - Maria

Currently there are 11 members on the board, 6 of whom will be at the end of their terms as of June, 2025. Maria hopes that these 6 will agree to continue on the WSB for another term in some role. Maria has been the chair for 2 terms now and feels it is time to rotate leaders as per our Traditions. She will stay on the board not as chair and is willing to help anyone who takes the Chair position as much as possible. She will be reaching out to board members who have been on the board for at least a year, about serving as chair. Treasurer and Chair cannot be spouses.

Greg has been looking for more board members from the Chicagoland Intergroup and will keep pursuing that. Lori is asking a member of the Parents of Adolescents group to join the board as well.

CLOSING

1. Announcements / items forgotten to mention:

Maria found that the Wordpress platform, which we already have for our website (and which got the best reviews) has a Plug-in Paywall which we can use to sell subscriptions to literature/resources. This seems like a clean way to go. Cindy raised the question from before when we discussed this, how do we keep the subscriber from sharing the literature with others? There may be safeguards to prevent that. Chris Y will take the lead and speak to Brian, Bob

and Maria will help out. There are many questions that the board will have to grapple with, but it seems doable,

Greg brought up 2 issues. First the 3 niche groups are all doing well, time to start thinking about starting some more. The spouse/S.O. group got a bump from an email Greg received from a spouse who wants an FA virtual group during the day when her spouse is out of the house. In general we need more daytime options, and Cindy suggested lunchtime might be an option especially if both spouses are working. Time zones may interfere with that, though. Greg, Judy and Lori met to discuss another niche group for Teens, most likely teen siblings but could also be teens partners or parents. Maria suggested that instead of posting the Zoom link generally, the teen group might need a person monitoring who gets on, etc. She will also reach out to her connections at AlAnon to find out what rules apply to teens in their AlATeen groups. What would be the age range for this group? Judy said she runs a group for 13 - 18 year olds and it is important to safeguard the ages in the group.

The second topic Greg brought up is the attendance by WSB members at Virtual FA groups. We want to create a warm connection between the WSB and the Fellowship. This effort may help struggling groups, and it might be a good way to identify new potential board members. Those that do it can share back to the board what they learn. There are currently 88 virtual meetings which will be divided up among Greg, Bob, Maria, and Chris Z on the board, as well as possibly Nadine (who is on the SM committee), Mike B and Jeff S, all of whom might be interested.

Cindy asked from the Convention planners, how many conventions have been held so far? No one knows the answer off the top of their heads.
