NEW BUSINESS:

1. Review of the Dashboard (Cindy C) (See Attachment A).

6. MOTION: Approval to invest in 12 month \$50,000 CD (Cindy)

MOTION: Move that the Families Anonymous World Service Board (WSB) Treasurer invest \$50,000 in an FDIC-insured 12-Month Certificate of Deposit (CD) with Chase Bank.

RATIONALE: Rates of return for CDs are currently higher than the rate earned from the fellowship's Savings account. The fellowship could earn more interest income while keeping funds fully insured by the FDIC. The fellowship's projected cash needs over the time period of a 12-month CD allow for this investment. The interest rate as of March 11, 2024, for a 12-month \$50,000 CD is 3.00% Annual Percentage Yield (APY). Note: rates are updated daily. At a 3.00% rate, the fellowship would earn approximately \$1,500 during the 12-month period of the CD. In comparison, the Savings account earns approximately \$24 annually. IMPLEMENTATION: On approval, the Treasurer is authorized to invest \$50,000 into a 12-month Certificate of Deposit with Chase Bank when the existing \$100,000 CD matures on March 25, 2025.
